We need to take into consideration the order that we receive the hauling out forms - the prevailing weather and available space at the time and height of the tide.

- RE-STEP MAST - Please also submit a separate Mast Form.** Masts must be prepared for re-stepping by the owner prior to submitting the launching request form. Owners will also need to complete and submit a separate 'Mast Form'.
